

School Nursing Service Year 1 Vision Screening catch up 2020/21

All area – version 1
Parent / Carer Information

Each year the Buckinghamshire NHS Trust (BHT) School Nursing Service routinely visit Reception Class in your child's school to undertake vision screening and height and weight measurements. However due to the Covid-19 pandemic we were unable to undertake this screening last year, but this will now resume for Year 1 children who are eligible and who have not had their eyes tested in the past 12 months.

The Screening Programme

The checks are carried out by a trained team of School Health Assistants, in a private space away from other pupils. Parents / Carers are requested to **opt-out of this if they DO NOT** wish their child to take part, see Opt-out process below.

<u>Vision Screening</u> – The NHS recommends vision screening before 7 years old to detect any problems early so your child can receive effective treatment. The test is carried out in school and individual results letters are sent to you. In some instances we may telephone you to discuss our findings and advise about a possible referral to the Hospital Eye Department (Orthoptic). It is important that your child's eyes are checked regularly by an optician, which is **free** to all school age children. If your child is being seen by the Hospital's Eye Department then please advise us of this. Please note we will not test children who wear glasses.

<u>National Childhood Measurement Programme</u> – Each year in England, School children in Reception and Year 6 have their height and weight checked at school as part of the National Childhood Measurement Programme. However, this was not possible for some children last year due to school closures as a result of the Covid-19 pandemic. Covid-19 Infection Control Process

Buckinghamshire Healthcare NHS Trust's, School Nursing Services will carry out the screening following government advice that aligns with national and local COVID-19 guidance for schools and infection control. Considerations and adjustments have been made to carry out the screening within the altered school environment with respect to class groups and minimising the number of school visits required.

The staff members who visit your school have clear guidance on hand hygiene, cleaning the vision screening equipment and the allocated room(s). The local authority and school nursing team will consider use of Personal Protective Equipment (PPE) as per BHT guidelines Pupils will not be required to wear PPE at any point during the screening process.
