## School Nursing Service School Entry Health Screening 2021 - Vision Catch up All Schools – version 7 Parent / Carer Information

# The Screening Programme

From September 2021, Buckinghamshire NHS Trust (BHT) School Nursing Service will be visiting Year 1 Class to undertake vision screening tests, which were not undertaken while in Reception class. The checks are carried out by School Health Assistants, in a space away from other pupils. Parents / Carers are requested to **opt-out of this if they DO NOT** wish their child to take part, if they are already under professional care, wear glasses or have had an eye test in the past 12 months.

#### COVID-19

BHT School Nursing Services will carry out the vision screening following government advice that aligns with national and local COVID-19 guidance for schools and infection control. The staff members who visit your school have clear guidance on hand hygiene, cleaning the vision screening equipment and the allocated measurement room(s). The local authority and school nursing team will use Personal Protective Equipment (PPE) as per current NHS policy. Pupils will not be required to wear PPE at any point during the screening process.

<u>Vision Screening</u> – The NHS recommends vision screening to identify children with reduced vision in one or both eyes. The aim is to detect any problems early so your child can receive effective treatment before they are 8 years old. It is important that your child's eyes are checked regularly by an optician, which is **free** to all school age children. If parents/carers would like to make your own arrangements, then please contact **your local optometry practice (optician) for your child to have a free NHS sight test**. <u>www.nhs.uk/service-search/find-an-optician</u>. The optometrist (optician) will be able to explain the results and any next steps with you during the sight test.

## Summary - How the data is used
