#### Ofsted Update

Well, after expecting our Ofsted visit around the time of the worst of the COVID-19 pandemic and then waiting to see when it would happen - it has finally happened!

As Chair of Governors, I was invited to be interviewed

alongside another governor, the Chair of our Cluster Board, and members of the Trust's governance. It was a nerve-wracking experience, wanting to represent the school the best we could and be sure we could answer the questions of the inspectors. In the end it wasn't so bad, they asked about governance and experience of the children, they triangulated our data and experiences, and I feel we reflected our support and challenge to the school well. Thanks to Laura Nunn for joining me in the interview and other governors for helping us prep.

As governors, we joined the inspection debrief following the inspection, and heard the verbal report from the lead inspector. As she spoke, I was glowing with pride, as I am sure others were. The way the inspectors spoke about the school reflected everything about it, its ethos and culture, its curriculum, its support for pupils and for each other as staff. That is testament to every member of staff who works at the school for showing the inspectors everything that is amazing about the school.

The report has now been published and is on the website for all to see; there are so many things it

recognises that we will continue to celebrate. The "Outstanding" judgement in Personal Development is well deserved as it recognises so many of the things about the school's approach. Of course, there are things to work on from the inspection, but they are things the school was already aware of and we as governors will continue to support them in everything they do.

#### **Class Visit Update**

I came to visit Year 4 as part of my routine termly visit a few weeks ago. I joined just as lunch was finishing and, as always, the behaviour of the children was impeccable as they returned to class.

I joined a PHSE class, something I had never seen before and wasn't really a thing when I was at school. It was lovely to see the school exploring different topics with the pupils and on the day, I joined it was about risk. As a programme management professional that made me smile a lot.

It was great to see the children discussing the possible risks and dangers posed by different scenarios and also thinking about how they could mitigate them. There were some very imaginative ideas thrown in there too.

Some of the children were asked to share their thoughts with the class and it was good to see them trying out public speaking in a safe environment as that is something that will help them in later life.

The class ended with a discussion about online safety and the risks and mitigations that there are – something that is so important in the times we live in.

Once again it was great to visit Year 4 and I look forward to seeing them again next term.

I was honoured to take on the role of Teaching Staff Governor at the beginning of the Spring term and I am learning the ropes from my fellow governors. As I do not take part in link visits in my capacity as a governor, I thought that I would share some of the work the school are doing around equality and diversity.

Another of my hats is Equality and Diversity Lead for the school, and over the last few years I have been working with all staff to develop and maintain an inclusive curriculum to ensure that people of all races, genders, sexualities, religions, disabilities, and ethnicities are visible and celebrated throughout the subjects. As a REAch2 appointed governor for Green Ridge Academy, I want to thank all the staff, parents, and children for contributing to Green Ridge Academy's first Ofsted inspection. I also wanted to update the wider Green Ridge community about my recent visit to Green Ridge and some of the training that governors must undertake to enable us to fulfil our duties.

I visited Green Ridge on the afternoon of the 22nd of March 2022. I met with newly appointed Deputy Headteacher Sam Kaye. I am the link Governor for Year 1, so I was able to discuss the progress of students against their age-related expectations. I also met with Vicki Gardiner, the SENCo and discussed the progress of SEND interventions and training for the staff who deliver bespoke support to children. It was also pleasing to hear that the first post-lockdown coffee morning for parents and carers of children with special educational needs took place in the Spring term, and I look forward to this informal network to continue to grow.

This term I have completed training in the following areas: 'Panel work: an introduction' and 'How to run an effective exclusion review panel.' It clearly makes an impact on the pupils having Mr Wanford take the time to do this each week, which leads to neatly to my final paragraph...
